COMPETITION RULES AND REGULATIONS

- The Organising Committee (Dressage NSW) reserves the right to refuse an entry if it is deemed unsuitable or unsportsmanlike for that class.
- Formal dress code will apply, coats must be worn. (White or fawn breeches only.)
- All scratching to be notified to Tina Stafford by email ONLY to tina.stafford@bigpond.com
- There will be no refund of entry fees for scratchings after the closing date.
- Stabling/camping will be refunded.
- All cabins are fully booked so please check with Toni Venhaus before booking a cabin (e-m: toni.venhaus@bigpond.com)
- After the event, DNSW will process refunds based on information provided by Jumping co-ordinators Jane Robinson and Tina Stafford.
- Refunds will only be given on receipt of an email as noted above.
- Refunds will be sent out within 10 days after the event.
- Ribbons will be presented at Arena 2 at the conclusion of each class.
- If entries are insufficient the OC may cancel the competitions and entry fees will be refunded.

Conditions of Entry

- All riders and owners must be current members of Equestrian Australia.
- All competitors from QLD must complete a bio security declaration and hand in on arrival at the event rider
 information office located at the entrance to the stables. The declaration will be sent out to all competitors
 prior to the event.
- The Event will be run under FEI/EA rules.
- Competitors competing in Jumping classes 1.05 and above must have Jumping Licenses.
- Australian, European & American helmets standards will apply.
- Bridle numbers are required for dressage only.
- All riders must wear riding boots and an approved helmet at all times whilst mounted, including presentations.
- Coats must be worn in all presentations.
- The Organising Committee reserves the right at their absolute discretion to alter or amend any of the conditions, regulations, or any aspect of the event as they see fit.
- The Organising committee reserves the right to swab horses. Random swabbing of horses may be conducted in any class. Horses chosen for swabbing must proceed directly to the swabbing box immediately after the presentation as directed by the Swab Steward.
- If my entries are accepted, I agree to abide by the rules, Regulations, and Conditions of Entry

General Information

- This event is held in conjunction with the Sydney CDI event conducted by Dressage NSW.
- Due to high number of spectators at this event Float/Truck parking around the Main Arena is not permitted. Cooperation is expected to ensure everything runs smoothly.
- Parking for Jumping competitors will be in in the day park area above the Main Arena or the North camping area unless otherwise instructed prior to the event or on the day by venue staff.
- Horses must be stabled if staying overnight.
- Competitors please make a note in the notes section of the entry if you are competing in the CDI dressage event.

- Admission on Saturday: Jumping/Eventing competitors and a groom per horse arriving with their horses will not be charged an admission fee. Competitors are welcome to remain on site and enjoy the Dressage. Please be aware that seating in the Indoor is pre-sold and seating on Saturday night is unlikely unless you have reserved seats. Standing room is available.
- Other persons will be charged an admission fee at the entrance:

- Parking/Stables/Camping & other Fees:
 - O Day parking available at a cost of \$25 per day.
 - Stables available at a cost of \$45 per day.
 - A stable bond of \$82 is payable and refunded after the event if stables left clean.
 - o Bedding \$15 per bale
 - Camping in North Camp area available at \$45 per night.
 - A \$10 administration fee is payable and non-refundable.
- 24-hour Stable Security is in place for this event. Competitors and one groom stabling horses will be issued a wrist band to access stables. Accreditation for access to stables available from the Rider Info Office located on the Event Square (in front of the stable block).
