CALL FOR NOMINATION FOR ELECTED DIRECTOR POSITIONS

NOMINATIONS of candidates for election as Elected Directors are hereby called.

- If the number of nominations received exceeds the number of vacancies to be filled a ballot shall be conducted to determine the Elected Directors.
