Attached is the current status of entries for the event. This is a preliminary indication only and some adjustments may be necessary if we discover problems such as: a horse in the wrong competition, missing entries or we are unable to resolve or verify some performances etc.

If your horse's name is missing or is noted as pending the reason could be that the horse has no performance at the level entered; the results submitted were below the required performance standard or not within the qualifying period. If you think we have made a mistake, please contact Toni Venhaus (contact details below).

We have taken as many horses as possible at each level but due to arena time available and other constraints there is a limit to the number of horses that we can accept but we will do our best not to disappoint.

CDI3*/U2-25/Y/J/P entries

We will be checking to ensure all horses and riders entered in the CDI competitions are current with their FEI registration and documents. Several horses and riders have yet to register on the FEI date base and those with "*tba*" on the list are to let us know as soon as the registration has been processed. Another list will be published when further checks are done with EA/FEI. Emails or messages sent to those who need to update their registration. Entries can't be entered into the FEI event system until all documents have been processed.

- All horses entered for CDIs, whether at home or in foreign countries, must have a current **Official FEI Passport or FEI Recognition Cards** or for CDI-J, CDI-Y, CDI-P, U-25 an EA National Passport approved by the FEI. (FEI Gen. Regs. Art. 137). FEI documents are available from EA National Office. Riders must ensure that they have the appropriate documents on arrival. Enquiries EA 02 8762 7777.
- **CDI-U25, CDI-Y, CDI-P, CDI-J:** FEI Passports and or FEI Recognition Cards are optional. Registrations from 1/1/17 horses need an EA National Passport.
 - **FEI Horse and Rider registration:** All riders and horses participating in FEI sanctioned events (CDI 3*, CDI-Y, U25, CDI-P-CDI-J) **must be registered on the FEI database.**
- **FEI Registrations must be renewed each calendar year.** Registration forms are available on the [EA web site](#). Or contact the National Office 02 8762 7777. Please note that this registration is required even if the horse has an FEI Passport or FEI recognition card.

Still confused, more information on [these guidelines](#)

registrations and passports need to be fixed asap and if the FEI registration for both horse and rider are not current, EA will not be able to lodge your entry. This applies to all CDI3*, CDI U25, CDI-Y, CDI-J, CDI-P.
